- 3. All grants shall be used for educational purposes, including but limited to art, reading, mathematics and science.
- 4. Grants will not be awarded for general operating expense, payment of salaries.
- 5. Grant funding limit for 2018 is \$10,000.00.
- 6. Roscoe Village Neighbors has appointed an Education Committee but the Board of Directors for Roscoe Village Neighbors shall have final approval of all applications.
- 7. Incomplete grant applications will not be considered.
